# THIRD SUPPLEMENTAL DECLARATION AND AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS

HIGHLAND MEADOWS, LLC, Developer, pursuant to authorization granted in Sections 14.2 of the Declaration of Covenants, Conditions, and Restrictions (Declaration), dated November 17, 2020, recorded December 16, 2020, under Document No.3369090, records of Lewis and Clark County, Montana, pertaining to the following described property:

Highland Meadows Subdivision – Phase 1, Lewis and Clark County, Montana, according to the plats on record in the office of the County Clerk and Recorder of Lewis and Clark County, Montana, under Document No. 3369086;

which Declaration was amended pursuant to the First Supplemental Declarations and Amendment to Declaration of Covenants, Conditions, and Restrictions, dated January 7, 2022, recorded January 10, 2022, under Document Number 3392643, records of the clerk and recorder of Lewis and Clark County, (First Amendment), to add Phase 2 to the property subject to the Declaration, and to make other changes more specifically described therein,; and was amended pursuant to the Second Supplemental Declarations and Amendment to Declaration of Covenants, Conditions, and Restrictions, dated February 14, 2023, recorded February 15, 2023, under Document Number 3408493, records of the clerk and recorder of Lewis and Clark County, (Second Amendment), to

### 2. Article XI, Section 11.4 is amended to read as follows:

#### 11.4 Fencing.

Fencing is required on all Lots within Highland Meadows Subdivision - Phase 1. The cost of the shared fence lines will be split equally between lot owners.

Fencing is optional for all lots in Highland Meadows Subdivision - Phase 2 and Highland Meadows Subdivision - Phase 3; Highland Meadows Subdivision - Phase 4. For Phase 2, Phase 3, Phase 4 and subsequent phases, cost sharing of shared fence lines is encouraged.

For all phases, whether required or optional, if fencing is installed, it must be installed on the property line and shall not extend beyond the front of the building and must connect to the dwelling unit. To ensure consistency throughout the Property, all fencing must be installed by the approved fencing contractor, (as determined by the Declarant), and shall be 6-foot-tall, tan vinyl privacy fencing.
